Lawrence County School Board Meeting
June 20, 2017

The Lawrence County Board of Directors met in regular session on Monday, June 20, 2017, in the boardroom of the Superintendent's Office. President Ron Ingram called the meeting to order and Clay Sloan offered the prayer. Greg Gill was not in attendance.

Superintendent Belcher presented the nurses' report to the Board as required.

Superintendent Belcher recommended the Board approve the Wellness Plan. Vickie Mitchell moved to approve the plan as presented. Brittany Schmidt seconded the motion. The motion received unanimous approval.

Superintendent Belcher recommended the Board approve the Title I, Title II-A, and the Title VI-RLIS budgets. Pat Roby moved to approve the plan as presented. Joe Penn seconded the motion. The motion received unanimous approval.
