Lawrence County School Board Meeting
March 14, 2016

The Lawrence County Board of Directors met in their regularly scheduled session on Monday, March 14, 2016, in the boardroom of the Superintendent's office at 5:00 p.m.

Vice President Ingram called the meeting to order, and Clay Sloan offered the prayer.

Pat Roby moved to approve the minutes as presented. Greg Gill seconded the motion. The motion received unanimous approval.

Vice President Ingram moved to the Superintendent's Report. The first item was Old Business. Superintendent Belcher recommended the board rehire the certified personnel for the 2016-2017 school year. Greg Gill moved to approve the recommendation. Joe Penn seconded the motion. The motion received unanimous approval.

Mr. Belcher recommended the board hire high school student, Dallas Moore as a bus rider. Joe Penn moved to accept the recommendation. Ron Ingram seconded the motion. The motion received unanimous approval.

In Other/ Miscellaneous business the Board was given activity calendars. Mr. Belcher informed the Board that Parent Teacher Conferences were scheduled on Thursday, March 19.
